## Use the online submission to get your rebate


Applying is easy as 1-2-3. Apply online – upload receipt – get paid!

1. To apply, go to <https://www.friedrichrebates.com> and click the 'Submit your Rebate'. You will be asked for the following information:
  - Purchase date
  - The Authorized Friedrich Dealer where you purchased your unit. Please note, the Dealer name you select must match the dealer on your sales receipt.
  - Model number
  - Serial number\*\*
  - Mailing & contact informationOnce you have entered all the necessary information, click 'Apply for Rebate'.
2. Upload a copy of your receipt (JPG, PNG, GIF, or PDF) and photo of the unit serial number. Your submission must include an itemized sales receipt and a photo or scan of the unit serial number/UPC. Incomplete submissions or those missing required documentation will not be accepted.
3. Upon review & acceptance of your submission, you'll be issued a Friedrich Prepaid Mastercard\*. Rebate payments will be fulfilled within approximately 6–8 weeks after your online submission has been successfully received and approved.

\* Purchases made from an Authorized HVAC Distributor, Parts Dealer, Service & Repair or Manufacturer's Rep Firm DO NOT qualify for a rebate.

\*\* The serial number will either be four numbers, one letter, and five numbers (1712A00123), or one letter followed by nine numbers (D012512345). The serial number can be found on the UPC Label on the box/carton your unit came in. You can also find it behind the filter of the unit on a bar code label.
